### **Acceptance of the Terms of Use**

These terms of use are entered into by and between You and Actuator Finance, LLC ("**Company**," "**we**," or "**us**"). The following terms and conditions, together with any documents they expressly incorporate by reference (collectively, "**Terms of Use**"), govern your access to and use of *actuator.finance*, including any content, functionality and services offered on or through *actuator.finance* and its subdomains (the "**Website**"), whether as a guest or a registered user.

The Website – whether hosted via a centralized host or on the IFPS – is an independent interface providing a nonexclusive application through which users may interact with the Actuator Protocol via self-custodial wallets.
